<u>Delinquent Report Information</u>

- If you have zero Total and Taxable Wages to Report: You are only required to file an Employer's Quarterly Tax Report (FC-20). The late filing penalty will be removed once the report has posted to your account. You may deduct the late filing penalty from the total amount due on this notice.
- To file paper reports: Online filing is recommended for all filers. Paper reports are accepted for quarterly filers only. Remit your delinquent report(s), payment coupon, and payment in the enclosed envelope or mail to: Virginia Employment Commission, Cashier's Office, P.O. Box 27592, Richmond, VA 23218. For any delinquent Employer's Quarterly Tax report (FC-20) you are submitting, compute tax and interest due and add this amount to the balance due on this notice. Interest is assessed at 1 ½ % of tax due per month or portion of a month from due date of return.

- Payments Received: Will be applied beginning with the earliest period having a balance due, first to penalties, and then apportioned to tax and interest before moving to the next period with a balance due.
