REQUIREMENTS FOR DESIGNATION

Examination Applicants (applicants who have passed the FE exam)

- *Engineer-in-Training Designation Application* and fee;
- *Degree Verification Form* or official school transcripts;

EDUCATION

All applications are evaluated based on the undergraduate degree held by the applicant (*unless the applicant holds a graduate degree which is ABET accredited at the graduate level*). Applicants should forward the *Degree Verification Form* to the college or university from which any degree(s) were obtained (unless official school transcripts are required). In order to receive the EIT Designation, candidates applying must submit a completed *Degree Verification Form* or an official transcript.

Applicants who have earned a degree from an institution outside the United States must have their degree authenticated and evaluated by an education evaluation service if credit is sought for this education. However, if the applicant also holds an equivalent or higher-level engineering degree from a United States institution where the program has been accredited by ABET, no evaluation is required; however, the degree must be verified using the ***Degree Verification Form*** or official transcript. The Board reserves the right to reject an evaluation submitted by an applicant. AN EVALUATION DOES NOT CONSTITUTE ABET ACCREDITATION.

Graduated from a non-approved engineering curriculum or from a related science curriculum of four years or more **and** possesses a minimum of two years of qualifying engineering experience.

REQUIRED DOCUMENTATION: Provide official college/university transcripts, *Degree Verification Form*, and *Experience Verification Form*.

Obtained, by documented academic coursework, the equivalent of education that meets the requirements of ABET accreditation for the baccalaureate engineering technology curricula, as determined by the Board **and** possesses a minimum of six years of qualifying engineering experience.

REQUIRED DOCUMENTATION: Provide official college/university transcripts, *Degree Verification Form*, and *Experience Verification Form*.

ALL EXPERIENCE MUST BE VERIFIED ON EXPERIENCE VERIFICATION FORMS AND SUBMITTED WITH YOUR COMPLETED APPLICATION PACKAGE.
