All applicants must meet the current eligibility requirements at the time the completed application package is received at the <u>Board office</u>. Completed application packages must include all required documentation, references, verifications, and fees. All forms must be legible.

EXAMINATION ON BOARD REGULATIONS & STATUTES

Applicants for licensure or certification are required to read and understand the *Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects Regulations* prior to applying for licensure or certification. Pursuant to Regulation 18VAC10-20-85, all applicants for licensure or certification must achieve a passing score on a Board-supplied examination pertaining to the Board's regulations and relevant statutes. After your application is received in the Board office, you will be sent an examination, which you are required to complete and return to the Board office for scoring; you will be notified if you do not achieve a passing score on this examination.

REQUIRED DOCUMENTATION

Examination Applicants with a Virginia Surveyor-in-Training Designation

- ➤ <u>Land Surveyor License Application</u> and fee; and
- ➤ <u>Experience Verification Forms</u> documenting a minimum of 4 years of approved experience under the supervision of a licensed land surveyor or a licensed Surveyor Photogrammetrists. Applicants holding a Virginia Surveyor-in-Training designation should note that any approved experience reported on your Virginia SIT Designation Application that exceeded the amount required to obtain your Virginia SIT may be applied toward the 4 years.

Examination Applicants with a *Surveyor-in-Training Designation* from another jurisdiction (applying for the PS and Virginia portion of the exam)

- ➤ Land Surveyor License Application, and fee;
- ➤ <u>Verification of Examination and Licensure Form</u> to verify a passing grade on the Fundamentals of Land Surveying (FS) Examination;
- ➤ <u>Degree Verification Form;</u>
- ➤ Official high school/college/university transcripts; Applicants who have earned a degree from an institution outside the United States must have their degree authenticated and evaluated by an education evaluation service if credit is sought for the education. The Board reserves the right to reject an evaluation submitted by an applicant.
- ➤ Completion of an apprenticeship program (if applicable); and
- **Experience Verification Form(s)** documenting the minimum requirements

Comity Applicants (licensed in another jurisdiction and applying for the Virginia portion of the exam)

- ➤ Land Surveyor License Application and fee;
- ➤ <u>Verification of Examination and Licensure Form</u> to verify a passing grade on the Fundamentals of Land Surveying (FS) and Principles and Practice of Land Surveying Examinations (verification of the FS Examination is not required if the exam was passed in Virginia);
- ➤ <u>Degree Verification Form(s)</u> or official high school/college/university transcripts.

Applicants who have earned a degree from an institution outside the United States must have their degree authenticated and evaluated by an education evaluation service if credit is sought for the education. The Board reserves the right to reject an evaluation submitted by an applicant.

- ➤ Completion of an apprenticeship program (if applicable); and
- **Experience Verification Form(s)** documenting a minimum of 4 years of experience under the supervision of a licensed land surveyor or a licensed Surveyor Photogrammetrists.

Regulation 18VAC10.20.360.B states in part: If the applicant does not meet the requirements for licensure in Virginia that were in effect at the time of original licensure, the applicant shall be required to meet the entry requirements current at the time the completed application for comity is received in the Board office.

Reinstatement Applicants (for those whose license expired five or more years ago)

- ➤ Land Surveyor License Application and reinstatement fee; and
- **Experience Verification Form(s)** to document experience from the date of expiration of the license to the present.

EXPERIENCE

All experience must be documented on <u>Experience Verification Forms</u>. Any experience verified on forms other than those provided by the Department of Professional and Occupational Regulation will not be considered. Resumes and attachments are not acceptable. Please refer to 18VAC10-20-295 and 18VAC10-20-340 of the Board Regulations for definitions of qualifying (professional) and non-qualifying (sub-professional) experience. No credit is allowed for non-verified experience.

TOEFL iBT

Applicants for licensure must be able to speak and write English to the satisfaction of the Board. Applicants from a non-English speaking country or a country where the primary language is not English, who have not graduated from a college or university in which English is the language of instruction, shall submit to the Board a TOEFL iBT (Test of English as a Foreign Language) score report that reflects a score acceptable to the Board. Score reports shall not be over two years old at the time of application.
