REINSTATEMENT FOLLOWING DISCIPLINARY ACTION Applied, Clinical, School Psychologists or School Psychologist-Limited

This application is for individuals who have had their license revoked by the Board, it has been three (3) years since the revocation, and they want to have their psychology license reinstated.

APPLICATION INSTRUCTIONS

Follow these steps to apply for Reinstatement of your Applied, Clinical, School Psychologist or School Psychologist-Limited license following disciplinary action:

- 1. **Review** the <u>Laws</u> and <u>Regulations</u> regarding the Practice of Psychology in Virginia to ensure you are applying for the correct application type and have met the requirements for this application type. **Application fees are non-refundable.**
- 2. Gather and Request ALL the necessary documents in the checklist.
 - a. Ensure you have included all the necessary documents as indicated by the checklist. A complete application provides the best opportunity to avoid delays in the review and approval process.
 - b. It is preferred that you mail necessary documents in one complete packet to the Board office.
- 3. **Mail** the application, non-refundable fee, and required documentation to:

- 4. Wait for the Board to review your application and reply to any correspondence from the Board.
 - a. Applications that are complete, fully documented and meet the minimum requirements for the Regulations Governing the Practice of Psychology will be reviewed within **30 days** of receipt of a **complete** application.
 - b. Incomplete applications remain active for one year from the date of payment, after which incomplete application files are destroyed as outlined in the Library of Virginia records retention and disposition schedules. If your application is not completed in the one-year timeframe, you are required to re-apply by submitting a new application, fee, and documentation pursuant to the regulations at that time.
 - c. Your online checklist will be your primary source of application status.
 - d. As documentation is received and reviewed, your checklist will be updated, and an automated email will be sent to you 24 hour later.

RULES AND GUIDELINES

- Please notify the Board in writing within 30 days of a name change or address change by completing the Name/Address Change Form.
- Providing false or misleading information as well as omitting information in response to information requested in the application or as part of the application process is considered falsification of the application and may be grounds for denial of or taking disciplinary action against an existing registration, certification, or license.
- Pursuant to Virginia Code § 54.1-2400.02 addresses of licensees are made available to the public. Normally, the Address of Record is the publicly disclosed address. If you do not want your Address of Record to be made public, you may provide a second, publicly disclosable address (e.g. work or practice address). If you would like your Address of Record to be publicly available, please complete both sections with same address on the application.
- Pursuant to Virginia Code § 54.1-116 (A), you are required to submit your social security number, or your control number issued by the Virginia Department of Motor Vehicles*. If you fail to do so, the processing of your application will be suspended, and fees will not be refunded. This number will be used by the Department of Health Professions for identification and will not be disclosed for other purposes except as provided for by law. Federal and state law requires that this number be shared with other agencies for child support enforcement activities. No license will be issued to any individual who has failed to disclose one of these numbers.
