*Required Attachments: Attach a completed **Experience Verification Form** and an official college transcript.*
2. Have a associates degree in waterworks, wastewater works or in a related physical, biological environmental or chemical science that includes a minimum of 20 credit hours in any combination of science and math; **and** 9 months of experience (with 3 months allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 4 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form** and an official college transcript.*
3. Have a high school diploma or GED **and** 1 year of experience (with 6 months allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 4 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form**.*
4. Have no high school diploma or GED, a Class 4 license, **and** 3 years of experience (with 1-1/2 years allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 3 facility or higher.

E. Class 2 Provisional Waterworks Operator applicants only:

Have a bachelor's or master's degree with a major in engineering, engineering technology, or in a related physical, biological, environmental, or chemical science that includes a minimum of 40 credit hours in any combination of science and math; **and** 1 year of experience, (with 6 months allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 3 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form** and an official college transcript.*
2. Have an associates degree in waterworks, wastewater works or in a related physical, biological environmental or chemical science that includes a minimum of 20 credit hours in any combination of science and math; **and** 18 months of experience (with 9 months allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 3 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form** and an official college transcript.*
3. Have a high school diploma or GED, **and** 2 years of experience; (with 1 year allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 3 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form**.*
4. Have no high school diploma or GED, a Class 3 license, **and** 5 years of experience; (with 1-1/2 years allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 2 facility or higher.

F. Class 1 Provisional Waterworks Operator applicants only:

1. Have a bachelor's or master's degree with a major in engineering or engineering technology, or in a related physical, biological, environmental, or chemical science that includes a minimum of 40 credit hours in any combination of science and math; a Class 2 license; **and** 2 years of experience, (with 1 year allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 2 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form** and an official college transcript.*
2. Have an associates degree with a degree in waterworks, wastewater works or in a related physical, biological environmental or chemical science that includes a minimum of 20 credit hours in any combination of science and math; a Class 2 license; **and** 3 years of experience (with 1-1/2 years allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 2 facility or higher.
*Required Attachments: Attach a completed **Experience Verification Form** and an official college transcript.*
3. Have a high school diploma or GED, a Class 2 license **and** 4 years of experience; (with 2 years allowed for substitutions) working as an operator or operator-in-training of a non-classified facility that is comparable in size and treatment process as a Class 2 facility or higher.
