Obtaining an instructor's license for Tattooing, Permanent Cosmetic Tattooing, or Master Permanent Cosmetic Tattooing requires a separate application process.

- ***** An individual holding a **Master Permanent Cosmetic Tattooing Instructor** certificate can teach permanent cosmetic tattooing without obtaining a separate Permanent Cosmetic Tattooing Instructor Certificate.
