This bond shall become effective on the day of , 20 , and shall remain in effect until such time as the surety withdraws the bond, giving thirty (30) days' written notification to the Commissioner of the Virginia Department of Agriculture and Consumer Services of such withdrawal. Failure to give such prior written notification shall result in the continuation of this bond's effectiveness. Withdrawal shall not release the surety from any liability for malfeasance, nonfeasance, or misfeasance that occurred prior to the effective date of withdrawal. Withdrawal shall not release the principal whatsoever.
