- The application is for **ENTRY LEVEL** and **IN-SERVICE** online training. This application does not schedule you for training. The online training is taken with an approved DCJS Certified Training School and you must register and pay that school for the training.
- **FOR ENTRY LEVEL:** A Fingerprint Application, Fingerprint Card, and \$50.00 non-refundable fee is required for certification pursuant to § 9.1-145.A of the *Code of Virginia*. Please ensure that a fingerprint package is submitted within 90 days of submitting the certification application. Note: a criminal history records check may take up to 45 days to process.
- **FOR ENTRY LEVEL:** Third Party Documentation verifying the types and dates or experience must be attached to this application. To be eligible the experience must be either:
 - **Three (3)** years managerial/supervisory experience in a private security services business, a federal, state, or local law enforcement agency or in related field

OR

 - **Five (5)** years general experience in private security, law enforcement, or a related field
