

NOTICE OF INTENT and CERTIFICATION

**DEQ Form YW-4
Exempt Yard Waste & Herbivorous Manures Compost Facility**

Facilities eligible for exemptions from Virginia Solid Waste Management Regulations (VSWMRs) included in 9VAC20-81-95.D.6 and 9VAC20-81-397.B.2 are required to submit a certification (Form YW-4) to the Dept. of Environmental Quality stating that the facility meets the regulatory standards necessary to operate an exempt composting facility. - To receive no solid waste other than yard waste and manures from herbivorous animals.
- That no open dump, hazard, or public nuisance will be created.
- All off-site manures are from herbivorous animals, will be incorporated into the compost within 24 hours of delivery, and limited to quantities needed to achieve a C:N ratio of 25:1 to 40:1.
- That no material will remain on-site, in any combination of processing time and storage time, for more than 18 months.
- If the total amount of waste received exceeds 6,000 cubic yards in any 12-month period, the owner or operator will submit an annual report to DEQ on Form YW-2 per 9VAC20-81-397.B.2.d.

Owner or operator affirms that the yard waste composting facility:

- Is not within an area designated as a flood plain.
- Is located no less than 300 ft from a property boundary of a parcel owned or controlled by another person, and is located no less than 1,000 ft from any occupied dwelling not located on the same parcel.
- Has at least one acre of ground suitable to receive yard waste for each 150 cubic yards of finished compost.
